2. **Place of Work** – Coast Guard units/ships at Maharashtra State (with all India service liability including Andaman & Nicobar).

3. **Description of duties**

(a) The post is that a Sweeper/ Safaiwala and the duties includes maintaining hygiene, sweeping, Mopping, Cleaning of drains, Cleaning of toilet, maintenance of septic tank/ sewer lines/Bathrooms onboard Indian Cost Guard Ship's, Shore establishment premises.

(b) Post is transferable anywhere in India (Mainland / Islands) subject to the exigencies of the Service.

4. **Physical Standards** Following are the requirement of physical standards:-

- (a) <u>Height</u> Minimum height requirement is **157 cms**
- (b) <u>**Chest</u>** Should be well proportioned Minimum expansion 5 cms.</u>
- (c) **<u>Weight</u>** Proportionate to height & age (+10% acceptable)

(d) **Eye Sight** : 6/60(Better) 6/60 (Worse) Without glasses & 6/9(Better) 6/24(worse) with glasses.

(a) **Written Test** All eligible candidates shall appear in a written test (50 Marks) comprising of General Knowledge and General English (Level of 10th standard). The duration of written test is one hour. Only those who qualify in the written test will appear in the "Professional Skill Test"

(b) **<u>Professional Skill Test (PST)</u>** The PST will be of qualifying/Not qualifying nature ('Q/NQ'). The skill test shall consist of following activities and one shall qualify in each activity.

(c) **Physical Fitness Test (PFT)** All those candidates who have qualified both in the Written Test and Professional Skill Test will have tqualify the PFT on the same day or on the next day. The PFT will be of qualifying nature ('Q/NQ'). The standards for PFT are laid down below:-

- (i) One mile/ 1.6 Km run within 07 minutes
- (ii) 20 Squat ups (Uthak Baithak)
- (iii) 10 Push ups

(d) Medical Standards Candidates who qualify in written test, PST and PFT will be subjected to a medical examination as per medical standards for Indian Coast Guard.

(e) Body Tattoo Permanent body tattoos are not permitted on any part of the body. However, certain concession are permitted to candidates belonging to tribal areas communities as declared by the Govt. of India. For other candidates, permanent body tattoos are only permitted on inner face of forearms i.e from inside of elbow to the wrist and on the reverse side of palm/back (dorsal) side of hand.

6. **Pay Scale**. 21,700.00 – 69,100.00 (Pay Level -03) and HRA, DA, TA, Medical Facilities and other applicable allowances as per Central Government rule.

7. In case of any injury / accident occurred during the test and PFT/PST Government will not be held responsible for any compensation / allowance.

8. Two sets of self-attested copies each of Aadhar card, educational/ technical certificate, Domicile Certificate from State Authority, Cast certificate (as per govt format) along with ten passport size photographs with blue background (other than affixed on form) should be attached with application. Candidates are to be in possession of all Original documents at the time of Recruitment/Written examination.

9. Selection of candidates is as per order of merit depending on their performance in Written Exam, PST/PFT and Medicals Fitness.


