## 2. Standard of Physical Fitness/Medical Examination:

Candidates shall be eligible for the engagement as act apprentice, duly satisfying the minimum standards of physical fitness specified in **Schedule-II** of **Apprenticeship Rules 1992** (as amended time to time) and Medical certificate in the prescribed format to be produced at the time of document verification.

The Medical certificates should be signed by Government Authorized Doctor (Gaz.) not below the rank of Asst.Surgeon of Central/State Government Hospital in terms Railway Board's letter no E(MPP)/2009/6/14 dated 04.12.2018.

### 2.1.a: बेंचमार्क दिव्यांग उम्मीदवारों की योग्यता/Eligibility of Person with Benchmark Disability Candidates:

Ministry of Law and Justice (Legal Department), Government of India Vide Gazette Notification No.59 of 28<sup>th</sup> December 2016, the reservation of persons with Disability (PWD) quota has been enhanced from 3% to 4% for the five categories of benchmark disability. Section 34(1) and The Schedule (Clause ZC of Section (2) of The Rights of Persons with Disabilities Act 2016 - defines the categories of benchmark disability and specifies the means of disabilities respectively.

Ministry of Skill Development & Entrepreneurship (MSDE)(Apprenticeship Training Division) vide Letter No.MSDE-4/3/2023-AP(PMU) Dated:11-04-2025, has advised the trade eligibility list of 266 designated trades under Apprenticeship Training Scheme as per RPWD Act, 2016. The engagement of apprentices in these trades is subject to the permissible disability are furnished hereunder;

**2. 1.b. Disability Certificates:**

Candidate's who wants to avail the benefits of reservation would have to submit disability certificate issued by the Competent Authority (i.e Medical Board constituted by the Central or State Government). Such certificate in the event of selection of such person for any post, will be subject to such verification/re-verification as may be decided by the competent authority.

Degree of Benchmark Disability for Reservation and Competent Authority for Issue of Disability Certificate: Only such persons would be eligible for relaxation in conditions/reservation in posts who suffer from not less than 40 percent of relevant benchmark disability. Those Persons with Benchmark Disabilities (PwBD) who have availed the relaxation and/or reservation and shortlisted for Document Verification have to submit Certificate of Disability issued by the Competent Authority as per the form V, VI and VII of rule 18(1) of the Gazette Notification (Extraordinary) dated 14 March 2024 of the Right of Persons with Disabilities Rules, 2017 under chapter 7 of Rights of Persons with Disabilities Rules, 2017 dated 15.06.2017. Refer Annexure-IV (A, B & C) for the revised formats. The existing certificates of disability issued under the Persons with Disabilities Act 1995 (since repealed) shall continue to be valid for the period specified therein.

The candidates with benchmark disabilities (PwBD) may note that they must select the appropriate PwBD sub-category i.e. LD/ HI/ VI/MD, while filling the application form as per their certificate of disability issued by the competent authority. No subsequent change of PwBD sub-category will be allowed under any circumstances. Such candidates shall have to furnish the requisite certificate from the competent authority as declared in the application form at the time of document verification.

*For candidates possessing X<sup>th</sup> through General Education Department, Government of Kerala the grades are classified on nine-point scale. Administration will take midpoint of range of grades obtained by the candidates. After obtaining midpoints of all the attempted subjects according to grades awarded, percentage will be calculated treating each subject is out of 100 marks as there is no standard method or multiplying factor for calculation of average of matriculation for such Boards.*

- b) For SC/ST and PwBD (PH quota) candidates the minimum percentage of 50% marks in aggregate in Matriculation is not insisted upon).
- c) In case of two candidates having the same marks, the older candidate will be preferred. In case the dates of birth are also same, then the candidate who has passed Matriculation Examination earlier will be considered.


