- 1. The candidates will have to deposit the fee in the shape of Demand Draft/RTGS/NEFT to the allotted Institute directly.
- 2. Final number of seats under each category shall be displayed on the admission web portal i.e. https://nursing.online-counselling.co. before the start of counseling. The candidates should regularly visit this website for updates.
- Reservation and relaxation in age etc. shall be provided to the candidates as per State Reservation Policy.
- 4. Any candidate who fails to deposit original documents and the requisite fees to the Institute as per the time prescribed in the schedule will not be considered and his/her claim to admission will be forfeited.
- Admission/registration fees shall be deposited by the candidate only through Net Banking/UPI and fees once deposited by way of any mode shall be Non-Refundable.
