EMPLOYMENT NOTICE

Applications are invited from eligible candidates to fill 15 (fifteen) posts of Stenographer Grade-III (English), which include 08 (eight) anticipated vacancies and 07 (seven) existing vacancies, purely on *ad hoc* basis, on a consolidated pay of ₹25,500/- per month (being the initial pay scale of a regular Stenographer Grade-III/Stenotypist), for a period of six months or till the regular appointments are made by the Hon'ble High Court of Punjab and Haryana, Chandigarh, whichever is earlier. The category-wise break-up of the aforesaid 15 posts of Stenographer Grade-III to be filled on *ad hoc* basis is as under:

The number of vacancies may increase or decrease due to creation or withdrawal of Courts or otherwise during the selection process. No intimation in this regard will be issued separately.

In case of non-availability of candidates belonging to reserved category, then the posts may be filled up from amongst the candidates available in unreserved category, subject to availability, in terms of explanation to Rule 7 of the Haryana Subordinate Court Establishment (Recruitment and General Conditions of Service) Rules, 1997.

ESSENTIAL QUALIFICATION

A person must possess a degree of Bachelor of Arts or Bachelor of Science or equivalent thereto from a recognized University and must have proficiency in operation of computers (word processing and spread sheets).

AGE LIMIT

No person shall be recruited to the service, if he/she is less than 18 years or is more than 42 years of age as on 01.01.2026. However, age relaxation for reserved posts shall be applicable as per reservation policy framed by Government of Haryana, from time to time.

MODE OF SELECTION

The candidate shall have to pass a test at a speed of 80 W.P.M in English Shorthand and 20 W.P.M in transcription of the same on Computer. He/she shall have to qualify Computer Proficiency Test (word processing and spread sheets). Marks of Computer Proficiency Test would not be counted towards the final merit as it is only qualifying in nature. Select list will be prepared on the basis of merit.

LAST DATE

The applications complete in all respect should reach in the office of District and Sessions Judge, Jhajjar, by **05:00 p.m.** on **17.02.2026**. No application received thereafter, shall be entertained in any case.

DATE AND PLACE OF TEST

The date, time and venue of Shorthand test/Computer Proficiency Test will be uploaded on the website of this office viz. <https://jhajjar.dcourts.gov.in/notice-category/recruitments/>. No separate letter/information will be issued.

INSTRUCTIONS

1. Format of the application form can be downloaded from the above-mentioned website of this office.
2. Applicants must attach self-attested copies of all relevant testimonials/documents along with their latest passport-size photograph, duly affixed on the application form.


3. Incomplete applications, applications submitted without the requisite documents, or applications received after the due date shall be rejected outright without assigning any reason. No correspondence shall be entertained in respect of such applications. Delay attributable to postal authorities or any other reason shall not be accepted as grounds for considering applications received after the due date. If, at any stage before or after the test, it is found that an applicant does not fulfill the prescribed eligibility conditions, his/her candidature shall be cancelled without notice.

7. No TA/DA shall be admissible to any candidate appearing in the Shorthand Test /Computer Proficiency Test.
8. After completion of the selection process, the final result shall be displayed on the above-said official website.
9. The decision of the Selection Committee in all matters relating to acceptance or rejection of applications, eligibility or suitability of candidates, and the mode/criteria of selection etc. shall be final and binding on all the applicants.
